Notes on Continuing Professional Development – Engineers Registration

There appears to be some misconception on what counts as CPD (Continuing Professional Development) with reference to Victorian Engineers Registration. As part of the Victorian Professional Engineers Registration Act, registrants need to demonstrate commitment to continuing professional development in keeping their skills current and in line with the highest standards of contemporary practice. This is also one of the corner stone of the Engineers Australia's CPEng chartership or Professional Australia's Engineer's RPEng

Register. One needs to accumulate at least 150hrs of CPD in a rolling three-year period. There are several ways that count towards CPD. For engineers who do not already hold a CPEng or RPEng status, this will be a new encounter. Some engineers that I have encountered recently thought that this meant attending an accredited training learning event. While accredited training is one means of accumulating CPD hrs, there are several other ways and accumulating enough CPD hrs may not be as daunting as it first appears.

At GREG, we aim to host events that have some learning value that can be counted towards CPD hours to enable our members to accumulate their CPD hours. These GREG hosted events would typically qualify under category Type II of EA's definitions or Type C of PA's definitions. The definitions include conferences, seminars, industry technical presentations, discussion groups, technical workshops and technical meetings. Under the registration scheme, in both the EA's chartership and PA's register, it is up to the individual to support the relevance of the each CPD learning towards their professional development. Keeping a detail CPD register is highly recommended.

Alternatively, if one was to prepare and deliver a technical presentation at a conference or technical meeting, this would also count towards the accumulation of CPD hours.

There is also another means of accumulating CPD hours and that is under Category V of EA or Category H of PA, called Service to the Engineering Profession.
